CONTRACT

AGREEMENT between Miniature Enthusiasts of Kingston & Area (MEKA) and (the dealer) so named on the attached contract form, for the MEKA Dollhouse & Miniatures Show and Sale to be held May 8th, 2010 at Portsmouth Olympic Harbour, 53 Yonge Street, Kingston, Ontario

1. Sale time is from 10 a.m. till 4:30 p.m. Setup time will begin at 7 am on May 8th,2010. Vendor tables are not to be removed/broke down prior to 4:30 p.m.
2. Rental of an 8-ft. table is \$65.00. Rental of half a table is \$35.00. Dealers should provide their own table coverings. Dealers may not extend their displays into aisles or to adjacent tables.
3. Electricity is available, upon request (indicate on form below). Dealers must provide their own lighting and extension cords. Please label your own equipment.
4. Tables may not be sublet.
5. MEKA reserves the right to remove from your vendor tables any items that are deemed unsuitable for the sale.
6. Dealers must display a Vendor's Permit and collect and return Provincial Sales Tax and Goods and Services Tax to the Retail Sales Tax Branch (if applicable).
7. MEKA and members shall not be liable, for any personal injury or damage to property. Dealers should and are expected to provide their own personal insurance.
8. There will be no refund after the acceptance of this agreement by both parties. In the event that the sales day cannot be held, this agreement will become null and void and the full amount of the table and/or space rental will be returned.
9. No smoking is permitted on the premises.
10. No pets are permitted on the premises.
11. Table allocations of the sales space will be made by the date of receipt of the completed contract/registration along with full payment.
